WBC – Reasons for the Refusal:

- 1. By virtue of the scale, mass and layout of the single storey rear extension, there would be an unacceptable impact on the size of the rear amenity space. As such, the proposal would subsequently contribute to the overdevelopment of the site. The proposal would therefore be contrary to policy CP3 of the Core Strategy, Borough Design Guide and the National Planning Policy Framework.

WBC - Reasons for the Refusal:

- 1. The proposed first floor rear dormer window extension, by reason of its size, form, design, positioning on the roof slope and clear visibility within the public realm, would result in an incongruous and contrived extension that would have a detrimental impact on the character and appearance of the main dwelling, the semidetached properties as a whole and the local area, contrary to policy CP1 and CP3 of the Core Strategy, the Borough Design Guide SPD and section 12 of the NPPF.
- 11.3 201969 Loddon Park Farm
 - *TPC comment on application The Committee wish to express their objection to this development as it is outside of the village envelope.

WBC - Reasons for the Refusal:

1. Prior approval is hereby refused as adequate provision of natural light in all habitable rooms of the proposed dwellinghouse cannot not be achieved contrary to the requirements of Class PA, Part 3 Schedule 2 of General Permitted Development Order as amended by the Town and Country Planning (Permitted Development and Miscellaneous Amendments) (England) (Coronavirus) Regulations 2020.
