Minutes of a meeting of the Parish Lands Committee held at 7.45 pm on Tuesday 17th January 2023 at Loddon Hall, Twyford, RG10 9JA.

1. Public Questions. None

- **2. Apologies:** Mr R Abeywardana & Mr J Bowley.
- 3. Declaration of interest in items on the agenda. None.
- **4. Minutes dated 8**th **November 2022.** Minutes approved as a true and accurate record. Proposed Mr T Winchester, seconded Mrs S Wisdom. Motion carried nem con.
- **5. Matters arising.** Agreed for Mrs Ashley to visit KGVR playground with a resident to review the height of the hedge dividing the two playgrounds. Mrs Ashley will report back to the chairman and any works required could be carried out under delegated authority.
- 6. Budgets and Precept
 - **6.1** To note updated charge sheets 2023/24 noted.
 - **6.2** To review budgets and precept
 - 6.2.1 Review the hedge laying budget suggest revising to zero (from £4375) agreed.
 - 6.2.3 Review the tree budget suggest changing to £2,000 plus £550 risk assessment (from £4000 plus £550) agreed.
 - 6.2.3 To consider budgeting funds for the volunteer groups £200 £500 approved. The committee agreed to increase the Lands Contingency from £3,000 to £3.500.
 - 6.3 To consider any cuts given that the precept is currently looking at a 35% increase. The Committee have agreed a budget lower than last years and cannot make any further cuts.

Proposed Mr T Winchester, seconded Mrs T Ramsden to approve a Parish Lands budget of £45,490 and precept of £39,775. Motion carried unanimously. Note: the budget includes ringfenced funds of £1,170 wildflower board, £4,375 Hurst Road allotment hedge laying and £170 Stanlake Meadow hedge laying.

8. Allotments.

8.1 Allotment matter (Part 2)

Proposed Mr T Winchester, seconded Mrs T Ramsden to move the meeting into part 2. Motion carried unanimously.

The Committee agreed that as confidential items were to be discussed the Chairman invoked Standing Order 1C "That in view of the special or confidential nature of the business about to be transacted, it is advisable in the public interest that the public and press be temporarily excluded and they are instructed to withdraw". A confidential set of minutes will record any decisions.

- **8.2** Osier Bed volunteers may be wishing to take this on. Decision as to whether the project should recommence. It was previously agreed to return the allotment to be let out no change in this decision.
- **8.3** Plot holder request to site a polytunnel (4.5mX3m) on plot HR56B approved.
- **8.4** Report of flooding possibly from the drain reported to WBC flooding line 09.01.23. WBC to attend. The clerk reported that WBC have attended. The problem appears to be running water and the incident has been reported to Thames Water.
- **8.5** Plot holder request to prune an Oak tree on their plot 80B at their own cost approved.

(not within budget) Proposed Mr T Winchester, seconded Mrs T Ramsden to **RECOMMEND to full Council** payment of £1,099.30. Motion carried unanimously. **10.3** RFS/2022/087828 Twyford Tennis Club, King George's Playing Fields, Twyford, RG10 9JA expiry of Temporary Permission for the clubhouse (2013) Extension to 03.04.23. Noted that the tennis club will apply for planning permission for the new building and to keep the temporary building in the meantime.
- **10.4** Possibility of a grass maze in the south westerly corner project joined with Twyford in Bloom. To consider the work hours of the Ranger or contractors if they are required to cut the maze. The committee were in favour of the maze and also the possibility of a monolith in the centre. Funding has been approved through Twyford in Bloom / Planning and Amenities committee and an application for a grant has also been submitted to Polehampton Charities.
