Highways

- ➤ WBC notified that the 40MPH signs from the village gateways near the Waggon & Horses are missing. WBC to investigate & replace.
- Resident's request for the foliage of the trees down the Waltham Road (Railway Bridge to Springfield Park junction) to be cut back and not overhang the pavement (photos taken). With Highways to investigate & arrange any necessary works.
- Resident's request for the foliage of the trees down the Wargrave Road to be cut back and not overhang the pavement between the Hermitage Drive junction and opposite the entrance to Lionel Court. With Highways to investigate & arrange any necessary works.
- Resident's request for a cedar tree down the Wargrave Road to be cut back (heavy branch overhanging the road). With Highways to investigate & arrange any necessary works.
- ➤ Fly-tipping (Estate Agents sign at Polehampton Close) W2346233. WBC have instructed the estate agents to remove the sign Ongoing.
- ➤ Notification of Temporary Closure A3032 High Street, Twyford between its junctions with A321 Wargrave Road and A3032 Old Bath Road. The alternative route for all vehicles affected by this restriction shall be via A3032 Old Bath Road, A4 New Bath

Road and A321 Wargrave Road or by this route in reverse. **Works requiring this restriction will take place between 8**th **March and 14**th **March 2023.** The reason for these prohibitions is to allow Thames Water contractors to undertake new service and connection work in safety. Access for residents and businesses within the boundaries of these restrictions will be maintained at all times.

 - ➤ To look into arranging a bus from Waltham St. Lawrence to Twyford.
 - WBC's Transport Team to investigate if this would be viable. Resident informed.
 - ➤ Rubbish collections should be the same as Windsor & Maidenhead. Recycling every week and rubbish every 2 weeks.

 - Food bags for the bins should be provided.

- Resident said there is a 1hr parking sign obstructing the driveway.
 - Referred to WBC's Highways Department for investigations and to carry out any necessary works. Email for resident is invalid.
 - Excerpt of response from WBC The residents have created further hardstanding in garden I assume to park additional car however to do this they would need to apply to widen their existing dropped kerb and move the pole at their expense.
- ➤ Hermitage Drive resident No disabled parking outside of the flats and when the school is open it makes it hard for residents to park.
 - Referred to WBC's Traffic Management Team for investigation & consideration.
 - Excerpt of response from WBC Disabled parking bays are put in outside particular properties and applications for disabled parking bays on the adopted highway have to come from individuals via an application form which is on our website. They have to provide proof of a disabled badge and that they received the higher rate of the mobility component of the Disability Living Allowance for their application to be considered. I presume you are referring to the flats in Anchorite Close or Thornbury Green and it appears from our maps that the parking area is not adopted highway so any requested would need to go to the landowner/management company.
